



## Foundation Website Legal Notices & Terms of Use

Welcome to the Foundation Platform website (the "Site", or The Foundation Site"). Please read these Terms carefully because they are a binding agreement between You and Treefrog Technology Group ("TTG", "We", "Our").

These Terms govern your use of our website(s) that link to these Terms. In these Terms, the word "Sites" refers to each of these websites and each of the services offered on Our Sites.
